It acquired four regional securities firms, served individual and institutional clients, and was a principal underwriter of companies. In 1985, IE merged with Southwest Securities of Dallas, Texas, which in 2015, merged into Hilltop Securities of Dallas.

It now contains an IMAX Theater, a world-class Sanctuary for problem grizzly bears and wolves, eight hotels/lodges, two banks, a WorldMark Condo development, a US Post Office, a RV Park, and numerous restaurants and retail establishments. In 1995 Firehole merged into Ogden Corporation (OG-NYSE) and operated as a wholly-owned subsidiary of Ogden, which in 2001 was renamed Covanta Energy Corporation (CVA-NYSE). While at Ogden, the IMAX movie *Amazon* was produced by the principals of Firehole.
